**NARRATIVE**

On 11/21/09 at approx. 0430 hours, I was dispatched to assist Ofc. Hoffman and Ofc. Kint at 821 W.14th Street.

As I arrived on scene, I went inside the house and watched Vierra, Sterling, and Barr while AMR was en-route. AMR arrived on scene and Transported Sterling and Barr to CCCRMC. I followed both AMR vehicle's to CCCRMC.

While at CCCRMC blood tech [REDACTED] arrived on scene to draw blood from Sterling and Barr. [REDACTED] struggled to find a good vein on Barr and was only able to draw two vials from Barr's left forearm. [REDACTED] was able to draw four vials of blood from Sterling's left forearm. I collected the blood sample kits and later logged them into evidence.

Barr was treated for his injuries and was medically cleared for incarceration by CCCRMC doctors. Sterling was also treated for his injuries and released for incarceration by CCCRMC doctors. I took digital photos of both of their injuries. The photos were later logged into evidence.

Barr was trying to use his cell phone while at the hospital, but I informed him that because he is in-custody he cannot use his cell phone. I collected the cell phone and logged it into evidence as safe keeping prisoner property.

Ofc. Graham transported Barr to MDF for booking. I transported Sterling for booking.
